

RECYCLED WATER COMMITTEE MEETING

MINUTES-

WEDNESDAY, SEPTEMBER 23, 2020 12:00 PM

1. CALL TO ORDER:

A regular meeting of the Santa Clara Valley Water District (Valley Water) Recycled Water Committee (Committee) was called to order via Zoom video teleconference at 12:00 p.m.

1.1 Roll Call.

Mr. Jerry De La Piedra, Assistant Officer, reviewed the information on this item, per the attached Committee Agenda Memo.

The Committee requested that staff follow up with the Office of Government Relations to determine the appropriateness of scheduling a meeting between Valley Water and City of Santa Clara elected officials, and noted the information without formal action.

4.2 Update on the Public/Private Partnership Implementation Approach for Purified Water Projects.

Countywide Water Reuse Master Plan - Update on the 6th Annual Independent 4.3 Advisory Panel Meeting.

Independent Advisory Panel (IAP) for evaluation of Santa Clara Valley Water District's Potable Reuse program and

efforts.

Mr. Medi Sinaki, Senior Engineer, reviewed the information on this item, per the attached Committee Agenda Memo, and corresponding presentation materials in Attachment 1.

The Committee noted the information without formal action.

4.4 Discuss the 2020 Recycled Water Committee Work Plan, Upcoming Meeting Schedule, and Next Meeting Date.

Recommendation: Accept the updated 2020 Recycled Water Committee Work

Plan and provide feedback on upcoming discussion items

The Committee noted the meetings scheduled for the remainder of 2020 occurring on October 28, November 25, and December 23, at 12:00 p.m.; requested the schedule for planned discussion of Work Plan items remain flexible for the remainder of the year and requested staff discuss agenda planning with the Committee Chairperson as needed, prior to the meetings; and confirmed its willingness to call special meetings to order, if necessary, to ensure continued progression of work.

5.1 Presentation of Public Perception Survey Poll Results on Advanced Purified Water and Public Outreach Update.

Recommendation: Receive information on survey results for tracking poll

carried out by EMC Research regarding public perception of advanced purified water and receive staff update on

public outreach efforts.

Ms. Marta Lugo, Assistant Officer, reviewed the information on this item, per the attached Committee Agenda Memo, and the corresponding presentation materials contained in Attachments 1 and 2 were reviewed as follows: Ms. Sienna Ziegler, EMC Research, reviewed the materials in Attachment 1; and, following a brief period where discussion on the item was tabled and then returned to, as indicated below, Mr. Ricardo Barajas, Program Administrator, reviewed the materials contained in Attachment 2.

Upon conclusion of Ms. Ziegler's presentation, the Committee noted that the Public Perception Survey Poll on Advanced Purified Water (Poll) had collected input from Santa Clara County registered voters only; expressed concern that Santa Clara County registered voters represented only a portion of Valley

Water's customer base; and requested that future polls include Valley Water customers who are not registered voters.

Director Kremen requested EMC Research representatives follow up with him individually to provide more information on the poll's datapoints. This information was sent to Director Kremen by EMC Research, subsequent to the meeting.

The Committee noted the information contained in the presentation of Attachment 1 without formal action.

Chairperson Estremera momentarily tabled discussion on Item 5.1 and returned the agenda to Item 4.1. Continuing discussion on Item 5.1 was held as indicated below.

4.1 Update on Purified Water Program including Partnerships with Cities of San Jose/Santa Clara and Palo Alto/Mountain View.

Mr. Mansour Nasser, City of Sunnyvale Water and Sewer Manager, encouraged by the progress of the development of the Cities of Palo Alto and Mountain View agreements, reminded the Committee about the City of Sunnyvale's interest in pursuing a similar water reuse partnership.

Chairperson Estremera returned the agenda to Item 5.1.
