HOW TO RECEIVE YOUR REBATE

FOLLOW THESE STEPS TO RECEIVE YOUR REBATE:

- 1. Review and adhere to the instructions and qualifications located on Valley Water's website that is applicable for the specific rebate(s) for which you are applying.
- 2. To obtain Valley Water's pre-approval prior to purchasing any equipment for which a rebate is sought, contact the appropriate staff person identified in the "Instructions and Qualifications" table above. Valley Water may inspect your facility before the equipment is installed. No retroactive rebates are available. Pre-approval is required before purchasing equipment for any rebate.
- 3. Once you obtain a Notice to Proceed from Valley Water, select and install the qualifying pre-approved equipment. Valley Water may inspect the equipment after it is installed.
- 4. Complete and submit to Valley Water via email, U.S. Mail, express delivery, or fax (see contact information below) all of the following required attachments:

□ This Commercial Rebate Program Application, which must be fully completed and signed (*Note: This* application must be signed by an authorized representative of the applicant, which is acknowledgment of the applicant's acceptance of terms and conditions contained in this application, including those terms in the section entitled "Agreement".); and

□ Receipts/Lease Agreement for the purchase/lease of qualifying equipment; and

□ A copy of applicant's water bill for the property where the equipment will be installed; and

□ A completed and signed W-9 form (*Note: Rebates of* \$600 or more may be considered taxable income by the *IRS/State*); and

□ All other paperwork applicable for the rebate sought as specified on Valley Water's website (*Note: Please see the Instructions and Qualifications section set forth above in this application*).

Once again, **EMAIL** the appropriate staff person identified in the "Instructions and Qualifications" table above. **MAIL** to: Valley Water, Water Conservation, 5750 Almaden Expressway, San Jose, CA 95118-3686. Please contact us if another method of submitting your application is necessary at this time.

5. A check will be issued within approximately twelve (12) weeks after Valley Water determines that the applicant has satisfied all requirements and is eligible to receive a rebate.

AGREEMENT

By signing below, you, on behalf of the business entity applying for the above rebate(s) ("Applicant"), acknowledge and agree to all of the following terms and conditions:

- 1) Valley Water is not responsible for any items lost in the mail or not received via the fax.
- 2) There is limited funding for rebates and no rebates will be issued after rebate funding is depleted. Rebates will be issued to qualified applicants on a first come, first served basis.
- 3) Valley Water reserves the right to verify Applicants eligibility, proof of purchase, and installation. If access to verify is denied, the rebate will be voided.
- 4) Applicant authorizes Valley Water to access Applicant's water use information for the purpose of evaluating the effectiveness of Valley Water's Commercial Rebate Program.
- Applicant hereby authorizes Applicant's water company to provide Applicant's water use information to Valley Water and for Valley Water to provide information related to Applicant's participation in the Commercial Rebate Program to Applicant's water company.
- 6) Applicant authorizes Valley Water to perform pre-installation and/or post-installation inspections of Applicant's installation site containing equipment or products for which Applicant received a rebate ("Equipment").
- 7) Applicant understands that failure to submit a complete Commercial Rebate Program application or failure to adhere to the rebate instructions and requirements may result in the rejection of Applicant's application.
- 8) Applicant represents and warrants that the Equipment was installed in accordance with all applicable laws, building codes, manufacturer's specifications, and permitting requirements, and, where applicable, by a licensed contractor.
- 9) Applicant represents and warrants that Equipment installed under the Commercial Rebate Program is not replaced with other equipment or products that are less water-efficient for at least five years after issuance of the rebate.
- 10) Applicant understands that rebates of \$600 or more may be considered taxable income by the IRS/State, and will be reported as income to Applicant on IRS Form 1099.
