ADDENDUM NO. 1
TO THE REQUEST FOR QUALIFICATIONS FOR PROGRESSIVE DESIGN-BUILD SERVICES
FOR SILICON VALLEY ADVANCED WATER PURIFICATION CENTER EXPANSION PROJECT

Notice is hereby given that the following revisions, additions, and/or deletions are hereby made of, and incorporated into, the Request for Qualifications (RFQ) for Progressive Design-Build Services for Silicon Valley Advanced Water Purification Center Expansion Project (PROJECT).

Section 2.6. Project Schedule

REPLACE the paragraph in its entirety with:

“2.6. Refer to Section 4.3 for the Procurement Schedule for the Progressive Design-Build Contract.”

Section 2.7. Project Labor Agreement

REPLACE the sentence that reads “As a condition of ...” with:

“As a condition of contract award, the Design-Build Entity must agree to comply with the terms of any Project Labor Agreement.”

Section 4.3. Procurement Schedule

REPLACE text for Item No. 2 in table that reads “February 11, 2016 at 10 a.m.” with:

“February 11, 2016 at 1 p.m.”

Section 4.4 RFQ Pre-Submittal Conference

REPLACE this section in its entirety with the following:

“A. A non-mandatory informational tour of the SVAWPC will be offered at 9:00 A.M. on February 11, 2016 to interested Design-Build Entities. The SVAWPC is located at 4190 Zanker Road, San Jose, California. It should be noted that this tour will be

conducted only by DISTRICT public information representatives, and that PROJECT staff and SVAWPC operations and maintenance personnel will not be in attendance at the tour.

- B. A non-mandatory RFQ Pre-Submittal Conference for interested Design-Build (and P3) Entities will be held at 1 P.M. on February 11, 2016 at the DISTRICT Headquarters Building Board Room located at 5700 Almaden Expressway, San Jose, California.
- C. During the RFQ Pre-Submittal Conference, the DISTRICT will discuss the procurement process, provide an overview of the EPWP, and make a presentation regarding the PROJECT.
- D. If there are specific questions you would like addressed at the RFQ Pre-Submittal Conference submit them to the district no later than Friday February 5, 2016. Questions must be submitted in writing to scvwdplanroom@valleywater.org. February 22, 2016 remains the final deadline for submitting questions.
- E. No additional conferences or site tours will be conducted or allowed during the RFQ process.
- F. Contact the DISTRICT Contact at least three (3) days in advance and provide the name and contact information of those planning to attend the SVAWPC tour and/or the RFQ Pre-Submittal Conference. All attendees will be required to show valid photo identification (CA Driver's License, CA Photo ID, passport) to gain entry to the SVAWPC. Due to space constraints, each firm will be limited to three attendees at the SVAWPC tour and/or the RFQ Pre-Submittal Conference. Attendees must be escorted by DISTRICT personnel while on the premises.
- G. Reasonable efforts will be made to accommodate persons with disabilities wishing to attend the SVAWPC tour and/or the RFQ Pre-Submittal Conference. Please request accommodations when confirming attendance."

ATTACHMENT C DRAFT INSURANCE REQUIREMENTS

SVWPC Expansion Project Stage 2

ADD the following item at the end of item 6. Surety Bonds on page 46:

"7. Pollution Liability

Design-Builder's Pollution Legal Liability in the amount of \$5,000,000 per occurrence and \$5,000,000 general aggregate limits, including pollution that occurs during transport.


Insurance must be maintained and evidence of insurance must be provided for a minimum of five (5) years following acceptance of the contract work by DISTRICT."
