

Lower Berryessa Creek flood protection project

Saturday construction work will begin on Lower Berryessa Creek starting June 23, 2018

Work on the Santa Clara Valley Water District Lower Berryessa Creek flood protection project continues with ongoing construction activities. Through the construction of floodwalls, improvements of levees; widening of the creek channel to accommodate high flows, and enhancement of wetlands and riparian habitat; this project will keep our communities safe and provide 100-year flood protection to more than 1,820 homes, schools and businesses in Milpitas. Crews are scheduled to proceed with their efforts along Lower Berryessa Creek in Milpitas, between Abel Street and Calaveras Boulevard.

Saturday work hours are from 9 a.m. to 5 p.m., starting June 23 through mid-October 2018. Regular work hours are 7 a.m. to 7 p.m., Monday through Friday.

The following activities are planned for this construction season:


- Installing concrete foundations and building concrete floodwalls on both banks near Abel Street Bridge.
- Raising the levee on the north bank downstream of N.

Milpitas Boulevard near the Hidden Lake community.

- Installing concrete foundations and building concrete floodwalls on the south bank downstream of N. Milpitas Boulevard near Edgewater Drive.
- Minor construction work including the installation of a fence, gate, and handrail between N. Milpitas Boulevard and Calaveras Boulevard.

We are working with the contractor to minimize impacts and disruptions as much as practical. We appreciate your patience and understanding as we continue work on the project. This is the final construction season for this phase of the project. Work activities within the creek channel began in May and will continue through October.

About the project:

The Lower Berryessa Creek Flood Protection Project will provide 100-year flood protection to more than 1,820 homes, schools and businesses in Milpitas.

The project is being implemented in three phases: Phase 1 was completed in December 2016, Phase 2 is in construction and Phase 3 is in the planning process.

Construction of Phase 2, from Abel Street to Calaveras Boulevard, began in 2016 and will continue through 2018. This is the final construction season for this section of the project.
