#### SUMMARY:

## 1. Update on Public Private Partnership (P3) Purified Water Project

Two major updates on the P3 Purified Water Project procurement process are being provided: completion of the evaluation of the Statement of Qualifications (SOQ) phase and the ongoing efforts preparing for the Request for Proposal (RFP) phase.

## Completion of SOQ Evaluation

Based on evaluation criteria that included organization and management, design-build, operations and maintenance, project understanding and financial qualifications, Valley Water staff completed their evaluation of the eight SOQs that had been submitted and notified the Respondents on November 2, 2021.

Based on the scoring, the three SOQs receiving the highest total evaluation scores will be invited

to proceed into the Request for Proposal phase of the P3 Purified Water Project procurement process.

Several Respondents requested debriefs which were held November 8th and 9th 2021. On November 9th, 2021, the fourth place Respondent submitted a letter requesting that the short-list be expanded to 4 Respondents due to a) the closeness of their score to the 3rd rated Respondent, b) the addition of a fourth stimulating competition and c) mitigation against potential loss of competition should another Respondent withdraw. They also acknowledged one of staff's concerns: that addition of a fourth respondent would increase direct and indirect costs to the evaluation process. Per Section 5.6 of the Request for Qualifications:

Valley Water anticipates shortlisting no more than three qualified Respondents; however, Valley Water reserves -at its sole discretion- the right to modify the number of shortlisted Respondents. Staff decided to expand the shortlist to 4 respondents. The shortlist will then be posted.

## Efforts Preparing for Request for Proposal (RFP) Phase of the P3 Purified Water Project

Work continues preparing the P3 Purified Water Project RFP, drafting the Project Agreement and developing the project technical requirements. Technical reports on underground conditions (e.g., geotechnical, utilities and environmental) are nearing completion. The draft Environmental Impact Report is anticipated to be released in the first quarter of 2022.

#### 2. Update on partnerships with Palo Alto and San José

Valley Water and City of Palo Alto staff have continued to collaborate on developing agreements for building the first phase of P3 Purified Water Project. Term sheets for lease and reverse osmosis concentrate management have been submitted to Palo Alto staff for review. In addition, staff have collaborated on Project HomeKey, outreach and coordinating with regulators.

The San José City Council and Valley Water Board acted on September 14, 2021 to direct staff to resume negotiations and engage a mutually agreed upon facilitator. Valley Water's Board directed staff to fund San José staff through December 31, 2021 to participate in discussions. Over the past month, Valley Water and City of San José and Santa Clara staff mutually agreed on a facilitator and held several meetings to discuss agreements that would be needed for the San Jose site to be the focus of the Purified Water Project. Unfortunately, the multitude of issues that would have to be resolved is not conducive to the P3 Purified Water Project schedule. Therefore, although discussions with the Cities of San Jose and Santa Clara have been productive, additional time will be required to assess whether they can partner with Valley Water on a potential future purified water project.

Based on the Board's direction to continue to advance the P3 Purified Water Project on schedule, staff believes that resources should be focused on finalizing agreements with the City of Palo Alto in order to proceed with the timely release of the P3 Purified Water Project RFP, while continuing discussions with the Cities of San José and Santa Clara for another potential future purified water project.

## 3. Meeting with The State Board's Division of Drinking Water (DDW).

The California regulatory agencies with primary responsibility for regulating potable water reuse projects are the State Water Resources Control Board (State Board) and the nine Regional Water Quality Control Boards (Regional Boards). The State Board is responsible for setting statewide water quality policy and water reuse requirements. DDW has statutory authority for regulating public water systems in accordance with the California Safe Drinking Water Act and water recycling systems as required by Section 13521 of the California Water Code. DDW does not have enforcement authority for state water recycling criteria; these requirements are enforced through permits administered by a Regional Board under the overall authority of the State Board.

These water reuse regulations and permit requirements are integral to shaping the detailed aspects of potable reuse. The intended uses of water supply and potential impacts to human health and the environment are the primary drivers of these state regulations and requirements. While the end use typically drives the selection of treatment purification, other factors are considered such as source control, monitoring, and response. Staff will discuss recent interagency discussions with DDW regarding groundwater protection and monitoring, regulatory coordination and communication, and development of a project-specific Engineering Report.

#### 4. Outreach.

Staff continues to host public and private virtual tours of the purification center. During the month of October, staff hosted 12 tours and reached over 400 members of the public. Staff hosted a VIP on-site tour for California State Assembly member Alex Lee on October 8. Staff met with the Congregation Etz Chayim of Palo Alto on October 28, as part of our continued engagement with the faith community to share information on purified water. On November 15, staff hosted a private virtual tour for the City of Palo Alto's Public Works Department. Staff also continues to outreach to key stakeholders on the Purified Water Project, including presentations to the Santa Clara Kiwanis Club and the Almaden Hills United Methodist Church. Valley Water is enhancing outreach to Santa Clara County on the importance of water conservation and Purified Water to our local water supply. This increased effort includes advertising on multilingual digital, radio, social media and television.

## SUBJECT:

South Santa Clara County Water Reuse Opportunities.

## **RECOMMENDATION**:

Receive information and provide feedback on South Santa Clara County Water Reuse Opportunities.

## SUMMARY:

The Santa Clara Valley Water District (Valley Water) and the Cities of Gilroy and Morgan Hill have a long history of collaboration to ensure the utilization and expansion of recycled water in South County. Since 1999, South County water reuse has been anchored by a series of partnering agreements that promote the development and expansion of our South County Recycled Water System. Valley Water has established the Joint Water Resources Committee (Committee) with elected officials representing the Cities of Gilroy and Morgan Hill to pursue relationships and formal agreements to support recycled and purified water expansion.

In August 2021, the Committee discussed Valley Water's Countywide Water Reuse Master Plan, opportunities to expand water reuse in South County, and development of a comprehensive water reuse agreement. Subsequently, the Committee recommended the establishment of a Technical Working Group (TWG) of agency staffs to further evaluate the opportunities and constraints of:

- One Comprehensive Water Reuse Agreement,
- Consistent water reuse terms and conditions countywide,
- Provisions to advance water reuse and purified water production, distribution, and wholesaling, and
- Cost sharing accord to integrate water conservation, reuse, and supply.

The Committee's recommendation was approved at a joint meeting of the Valley Water Board and the City Councils of Morgan Hill and Gilroy. In October 2021, the joint Water Resources Committee agreed to hold quarterly meetings beginning in January 2022 and receive updates on interagency collaboration from the TWG. For this committee update, staff will discuss recent (11/17/21 meeting) interagency discussions regarding South County recycled water master planning efforts, options to strengthen and enhance current and future recycling, and a roadmap to update our water recycling

agreements and improve South County water reuse.
