9.1 UPDATE FROM SANTA CLARA VALLEY WATER DISTRICT YOUTH COMMISSION'S WORKING GROUPS

Chair Ms. Anika Kulkarni reviewed the agenda item and received Youth Commissioner's reports for the working groups:

The Youth Commissioners and Valley Water Staff reported on the following Working Groups' activities:

Ms. Vaibhavi Kulkarni reported on the Youth Citizen Science Network (YCSN), participated in giving a Youth Commission overview presentation to 30 Santa Clara County High School Teachers attending the Baywork Ignited Teacher Externship Week in July 2021, a time to promote the youth commission to the high school students, sent email invitations for a virtual tour of the Silicon Valley Advanced Water Purification Center to 6 youth commissions in District 7 included, Palo Alto, Los Altos, Los Altos Hills, Mountain View, Los Gatos, and Monte Sereno. This will be expanding to other youth commissions in district's 1 through 6, to get more youth involvement and make them aware of the purified water efforts given the drought emergency. There were no meetings this summer but looking forward to meeting soon.

Ms. Kristen Yasukawa reported on the Public Art, recapped the Adopt-A-Bench's successful completion and the virtual ribbon cutting ceremony, the new pilot mural project working again with Mr. Paul J. Gonzalez, a local artist in San Jose, working on designing and painting a mural at Valley Water's Blossom Hill Annex site where it will be visible from the street, located by the creek, trail, and a VTA stop.

Ms. Sherilyn Tran reported on the Communication/Public Outreach, there were no meetings this summer, however, the group's focus is on public outreach efforts on events that occur, worked on the recruitment flyer for the commission's vacant positions, and development of the Youth Commission website.

Ms. Mera Burton reported on the Job Shadow Day/Mentorship. there were no meetings this summer but looking forward to working on the planning and promoting the Job Shadow Day event scheduled for February 2022. The working group will be working with Ms. Mera Burton, Ms. Perla Montes de Oca and Ms. Noemi Agagianian.

Ms. Anika Kulkarni reported on the Coastal Cleanup event, September 18, 2021, will be in-person around the creek behind the Valley Water's Headquarters, beginning at 9:00 a.m. to 12:00 p.m., there will be supplies, snacks, and since the commissioners are youth, a signed waiver will be required to be turned in at the event, and social distancing will be in place, this is a public event. There will be an Eventbrite page available. The working group is working with Ms. Julie Abbatelli and Ms. Lilian Bui
