SUMMARY:

Santa Clara Valley Water District (Valley Water) joined the Los Vaqueros Reservoir Expansion Project (LVE Project) Joint Powers Authority (JPA) through Board of Director approval of the Joint Exercise of Powers Agreement on August 24, 2021; JPA paperwork was filed with the State by Contra Costa Water District on October 6, 2021. The JPA includes seven other local agency partners (LAPs, Attachment 1). Director LeZotte was appointed to represent Valley Water on the JPA Board with Director Varela as the alternate. This presentation includes an update on JPA activities and the current timelines for the LVE Project.

Background

CCWD estimates the total LVE Project development and construction costs to be \$951 million (\$827) million in 2021 dollars). Federal and state environmental review is complete and neither received legal challenges nor significant public opposition. The project is now overseen by a JPA Board, made up of one representative and one alternate from each of the eight member agencies (Attachment 1). DWR is an ex-officio member that does not have voting rights and has not yet appointed anyone to the JPA Board. The JPA Board will be responsible for project planning, construction, and postconstruction activities including operating the facilities, ensuring adequate funding, facility maintenance and repair, and delivering project water.

Joint Powers Authority

The JPA Board meets the second Wednesday of every month, and its first meeting was November 10, 2021. JPA meetings have focused on administrative issues required for the JPA to properly oversee the LVE Project. Staff has been providing briefings to Directors LeZotte and Varela on JPA agenda items and has arranged for briefings from JPA administrative staff. Over the first three meetings the JPA Board has:

- Appointed Interim Administrator positions
- Approved an Administrative Agreement with CCWD
- Approved public records act request guidelines
- Established Board committees (Operations and Engineering, Finance, and Communications and Outreach)
- Discussed Authority bylaws and a purchasing policy,

Over the next couple of months, committees will begin meeting to develop and negotiate funding agreements, service agreements, and ensure proper and timely progress on project design and construction. By the end of the year, the JPA Board will need to approve an Interim Funding Agreement, Facilities Usage Agreements, and Service Agreements to meet the requirements for final WSIP funding and start construction next year.

Valley Water Participation

Attachment 2 provides scenarios for Valley Water participation in the LVE Project. Five levels of participation in conveyance and four in storage are identified. Total 100-year costs vary from \$10 million to \$500 million. By late summer this year, the Board will need to decide whether to participate in the LVE Project and at what level in order to negotiate a Service Agreement by the end of the year. If the Board decides against participation, it will need to withdraw from the JPA. Under the JPA Agreement, any agency can withdraw up to the final WSIP award without incurring future obligations, but from a practical standpoint that decision should be made prior to the start of negotiations for Service Agreements in late summer. Staff will bring additional information and a recommendation to the committee in the coming months based on the feedback received.

Los Vaqueros Expansion Participation Scenarios

Valley Water has been analyzing participation in the Los Vaqueros Reservoir Expansion Project (LVE Project). In the next year, Valley Water will need to formally decide whether to participate in the LVE project, and if so, at what levels of conveyance and storage. Five potential levels of participation in Los Vaqueros conveyance facilities and four different levels of participation in storage are discussed below. The 100-year cost and the cost for the next 10 years are provided in tables at the end. Estimated conveyance flows and storage usage are based on previous modeling conducted with Contra Costa Water District (CCWD). Hydrologic conditions significantly influence the annual usage.

Conveyance Options

Minimal Participation – average: 1,000 AFY; max: as much as possible

LVE facilities would be used for special or emergency circumstances. Contract water would continue to be delivered via existing facilities unless there was an emergency that required an alternative pathway. In an emergency, as much capacity as available would likely be needed to deliver contract and transfer supplies; however, all other partners would be in a similar situation and demand for conveyance capacity would be high. As a small partner in this scenario our ability to obtain capacity may be limited.

Surplus Flows - average: 3,000 AFY; max: 6,000 AFY

Valley Water could take direct delivery of surplus flows via Transfer-Bethany Pipeline (TBP) if there is a water supply need or storage space for additional supplies available. Surplus supplies are more available in wet years when there is typically less need. Valley Water could also use capacity during emergency circumstances.

LVE Storage – average 5,000 AFY; max: 15,000AFY

If Valley Water uses storage in Los Vaqueros it can store contract and surplus supplies for use in dry years. Water would be conveyed to the reservoir in wetter years and then conveyed to Valley Water via TBP in drier years. The amount of water stored and conveyed would depend on how water to Los Vaqueros is prioritized relative to other Valley Water storage options.

Regional Water Projects – average 11,000 AFY; max: 18,000 AFY (RRWE)

Two regional water exchange projects that Valley Water participates in are the Refinery Recycled Water Exchange (RRWE) and Bay Area Regional Desalination. Both projects develop new water either via water recycling or desalination, where that new water supply will go to CCWD customers. In exchange for the developing the new supplies, the freed up CCWD CVP supplies will be given to Valley Water via the Transfer Bethany Pipeline and South Bay Aqueduct.

Maximum Conveyance – max: 30,000 AFY

The maximum volume of water Valley Water would likely convey in a single year would be 30,000 AF if the full volume of storage was delivered in a single year.

Storage Options

No Storage

Valley Water may participate in conveyance only. Valley Water would continue to store water in existing facilities and could add storage capacity with Pacheco Reservoir and/or groundwater banking opportunities.

Shared Storage

Valley Water could share unreserved capacity in Los Vaqueros. Shared storage may be useful for limited amounts over short periods. For example, to store surplus water in a wet year for delivery a year or two later when there would be more opportunities for direct use or local storage. Currently, SFPUC and EBMUD have stated their desire for dedicated storage, totaling 70,000 AF of the available 115,000 AF of storage. The remaining 45,000 AF would be available to the other five partners to share. Shared storage capabilities would need to be negotiated as part of the service agreements. If the Joint Powers Authority (JPA) permits shared storage, unused capacity would likely be available to any partner. The cost estimate in tables 1 and 2 is based on each agency equally using and paying for the shared storage portion of the reservoir.

Dedicated Storage

Valley Water can reserve a fixed volume for its exclusive use to diversify Valley Water's out of county storage. CCWD and Valley Water modeling to evaluate cost has focused on Valley Water using 30,000 AF of the remaining 45,000 AF, but actual partner shares will be negotiated by the JPA as part of the service agreements.

Project Cost

Two tables are presented below. The first is total projected 100-year cost presented in current dollars. The second is estimated costs over the next 10 years (2022 through 2031). Costs are estimates based on financial modeling conducted by CCWD (Proforma models). The Proforma models are based on the requested use by each partner, estimated construction costs and financing, usage fees as currently negotiated between the partners, and power and fixed operations and maintenance costs. Each of these cost factors is subject to change as each agency negotiates with the JPA.
